Air Care Station Locations and Cost There are more than 130 Air Care Stations located throughout Albuquerque-Bernalillo County. Air Care Stations are required to clearly post their test fees on their official sign. Fees are set by individual test stations and usually about \$25 plus tax. Motor vehicles are a major contributor to ground-level ozone in the Albuquerque-Bernalillo County area. The emissions testing program was started in 1983 to reduce pollutants from motor vehicles that contribute to ground-level ozone. Emissions testing is required for motor vehicles, including gas-electric hybrid vehicles, registered or commuting in Albuquerque-Bernalillo County. All 1991-and-newer vehicles under 10,001 lbs must pass an emissions test. Passing test results are good for 1 or 2 years, depending on the type of vehicle. Gas-electric hybrid vehicles are required to be tested every 2 years, and any certified Air Care Station can test a hybrid vehicle. An emissions test is also required at change of ownership. VPMD will send a letter to the registered owner of the vehicle informing them of a possible problem with the vehicle and encouraging them to have it inspected. There are currently over 500 active inspectors working at 130 certified Air Care Stations. VPMD trains and certifies over 180 new Air Care Inspectors each year. A two-part training course is required for new inspectors, and inspectors must complete annual re-certification. Information for Current and Future Air Care Facts Air Care Facts in Spanish Emissions testing is required for motor vehicles that are registered in or commuting to Bernalillo County. THINGS TO KNOW New Mexico emissions tests must be performed on all Bernalillo County vehicles 35 years old and newer. Diesel vehicles are exempt from emissions testing. Dedicated electric vehicles (100% electric) are exempt from emissions testing. Vehicles weighing more than 10,000 lbs do not require an emissions test. Any vehicle (including gas-electric hybrid vehicles) must pass an emissions test every two years, or any time the vehicle's ownership changes, even if the emissions inspection sticker has not yet expired. Motorcycles, ATV's, boats, and scooters do not require an emissions test. New Mexico Vehicle Emissions Testing Includes The Following Procedures Pollution control equipment check that includes the catalytic converter and other connections. On-Board Diagnostic (OBDII) computer car emission test on vehicles 1996 and newer. Any visible car smoke test to uncover burning oil or poor fuel combustion that results in toxic emissions. Gas cap check to search for vapor leaks. Tailpipe exhaust analysis on vehicles manufactured between 1963 and 1995. Emissions testing checks the air care database for city regulated and required compliance. The air care database is administered and maintained by Albuquerque Air Care. If a failure or expiration notification from the air care database is returned, customers will be told to get their vehicle repaired and retested. If the vehicle passes emissions, the customer will be allowed to continue the transaction. In case of Emissions Test failure If the emission test fails, you have the option to get an extension through the Vehicle Pollution Management Program at 1500 Broadway Blvd NE, Albuquerque, NM, 87102.
