

Effective 1 January 2012, the jurisdiction of all new appointed public notaries extends to any county of the State and will not be limited to the counties of their residence. Code of Alabama § 36-20-70(a). The existing public notaries before 1 January 2012 continue to work in accordance with their existing authorities for the rest of their existing commission. Alabama Code § 36-20-70(b). Code § 8-21-1201, "Publics are entitled to request and receive reasonable taxes and compensation for notable public services." How do I manage a complaint about the conduct of a notary? As for the criminal conduct of a notary, the Attorney General Parere n. 07-157 states: "Pursuant to Tenn. Code Ann. § 8-7-103, the District Attorney General has the duty to pursue all violations of state criminal acts committed by the notaries. A citizen wishing to file a criminal complaint against a notary public can do so by contacting the district attorney general of the judicial district where the alleged criminal behavior occurred and proceeding through the prosecution." In addition, as explained in the previous opinion of the Attorney General, a notary can be removed from the office through the ouster procedure provided in Tenn. Code Ann. § 8-17-101. A directory of district attorneys can be found at the general directory of the notary commission is issued by the governor. A notary is entitled to the following fees: \$1.50 plus shipping for all services rendered in connection with the protest of any exchange invoice for acceptance, or of any exchange invoice, promissory note, check or other deed for payment \$.50 for any oath, certificate or seal taken \$.50 to give copies from the notarial register \$.25 for each record of each copy Does a public notary have to keep records of every notarial deed? Yeah. Every notary must keep a register of all notarial acts performed.
